



1 MINIMUM REQUIREMENTS

For every person working on a TAQA worksite, completing the training requirements below is mandatory.

Please find all minimum training requirements below. We kindly ask you to read them carefully and ensure all personnel working at a TAQA worksite has completed them.

VCA-Vol for Supervisors (dispensation for NEBOSH, MVK, HVK or MOSHE or senior managers not being part of a work party)
VCA Basic or MIST for non-supervisors
HSE Life Interactive Induction Onshore
HSE Life Permit to Work (PtW)
HSE Life Last Minute Risk Analysis (LMRA)
HSE Life Task Risk Analysis (TRA)
Only applicable if the individual is working under a permit (signed onto the workparty declaration) and/or is the permit holder/author
TAQA Specific Induction
